A person seeking nomination as a candidate of a political party must be a member of that political party for 365 days BEFORE the beginning of the qualifying period. Additionally, the law requires a person seeking to qualify for office as a candidate with No Party Affiliation to not be a member of any political party for 365 days BEFORE the beginning of the qualifying period. Therefore, the last day for such person to make the applicable change is **June 11, 2023**, for the person to meet the 365-day requirement.
